The undersigned absolves the Museum of all responsibility toward the holders of such rights regarding the reproduction or use of the material.

## Information on personal data treatment (Article 13 of Legislative Decree No. 196 of June 30, 2003)

1. Pursuant to Legislative Decree No. 196 of June 30, 2003, the treatment of data gathered by *Museo Nazionale del Cinema* for the performance of its services will be carried out only in compliance with the institutional purposes arising from the quality of the Users of such services. The treatment of data gathered to complete, update or disclose statistics on the number and composition of the Users and the use of the documentary materials of the *Museo* will be carried out exclusively in such a way to guarantee anonymity. The delivery of the data and the relevant treatment are necessary for the ordinary activity of the *Museo* and the protection of the documentary materials; any refuse to provide them may cause a total or partial denial to supply the services, as well as the impossibility to access to the borrowing of the material stored by the *Museo*.

2. The treatment of data shall be performed pursuant to article 11 of the Italian Legislative Decree No. 196 of June 30, 2003, in order to guarantee their safety and privacy. The treatment shall be performed with any support (such as paper, IT or telematic means) and will also include their processing according to qualitative, quantitative and temporal criteria. Only authorized personnel (personnel of the *Museo* or personnel charged with the management and maintenance of the IT) will have access to and therefore have knowledge of such data. Except for any disclosure permitted by applicable law or contract, the data gathered and treated shall not be transferred to third parties for any reason whatsoever.

3. ## Legislative Decree No. 196 of June 30, 2003 Art. 7 – Right to access to personal data and other rights

1 The interested person has the right to obtain confirmation of existence or not of any personal data that may concern him, also if data is not yet registered, and has the right to have is data communicated to him in a comprehensive form.

2. The interested person has the right to obtain indication of the following:

- a) origin of personal data;
- b) purpose and way of handling;
- c) applied logic if data are handled by electronic devices;

d) identification data of entitled handler, responsible and other representant named as contemplated by article 5;

e) subject or categories to whom data may be communicated or that may knowledge the data as nominated representant, responsible or delegated by the handler.

3. the interested person has the right to obtain

a) updating or, if it is his will, integration of data;

b) cancelling, transformation in anonymous form or stoppage of data handled in violation of the law, also of those data of whom conservation is not needed in relation to the purpose for which they have been collected or subsequently handled;

c) any person to whom the data are communicated have been informed about operations contemplated at points a) and b) and their content, except the case of impossibility or excessive cost against protective rights.

4. The interested person has right to oppose, also in part:

a) for legitimate reasons the handling of his personal data, also if pertinent to purpose of collection;b) handling of personal data to the purpose of advertising or direct selling or for market research or commercial communication.
